How Solar Works: When sunlight strikes the cells of a solar panel, it causes the electrons to flow, creating an electrical current. This energy is channeled into an inverter where it is converted from direct current (DC) power to alternating current (AC) power to provide energy to your home. As part of Utah, Moroni residents are ideal candidates for optimal solar energy absorption. When you choose to have a grid-tied solar system installed, you''ll receive a credit for the excess energy you produce, effectively reducing or eliminating your utility bill.

The 30% Solar Investment Tax Credit has been extended through 2034! This means homeowners in Moroni UT can receive a 30% tax credit through 2032. Then in 2033 and 2034, it will go down to 26% and 22%, respectively, before going away in 2035. Commercial solar installations in Moroni can still benefit from a 30% credit through 2024.

Keep in mind that a tax credit works differently than a tax deduction. A credit means you"ll be that your tax liability will be washed away on your taxes for the qualified amount. For example, if you pay \$20,000 for a 6kW solar system in the current tax year, you"ll be credited \$6,000 on your that year's tax returns, bringing the cost of your unit down to \$14,000 WHILE saving \$6000 in taxes!

In addition to paying cash, there are several financing options for solar in Moroni UT. The most popular options are home improvement loans or home equity loans. Many of these are available for little to no money down and still allow you to take advantage of the federal tax credit. And, unlike other home improvements, not only is the solar purchase itself tax exempt, the value added to your home is also exempt from any increase in property taxes in Moroni.

Solar panel installation provides Moroni residents and business owners with a relatively quick ROI by immediately reducing or eliminating your electric bill and adding tax-exempt value to your home or property. This is true even if you have a loan, as your monthly loan payment is typically less than your monthly electric bill. On average, the value added to your home is approximately 4.1%, according to a Zillow analysis conducted in 2019.
