First, USAID engages with institutions and businesses to promote renewable energy through policy reforms and events. Most recently, USAID co-hosted the Kosovo Solar Forum. Held on July 21st and 22nd, participants discussed investments into the "prosumer" (an entity that both produces and consumes electricity), self-consumption markets for small-scale solar power, and the upcoming solar auction, an open procurement process for large-scale solar projects in Kosovo.

Through innovative initiatives like the rooftop solar assessment, USAID is helping to increase awareness of

and build the enabling environment for climate-friendly, sustainable electricity generation across Kosovo.
